*Requirements for Registration*  
**Students new to Miami-Dade County  
Schools**

- **Original birth certificate**
- **Proof of current address (2) required**  
**FPL bill (current and under the parent's name),**  
**and one of the following:**
  - Fully executed notarized lease**
  - Warranty Deed**
  - Homestead exemption**
- **Both Blue and Yellow Medical HRS Forms:**
  - Blue is for the child's immunizations**
  - Yellow is proof of physical and TB screening**
- **Last report card, any standardized test scores, and/or any pertinent or necessary information for students, particularly if the student is in a special educational program... (IEP), (EP).**

STUDENT MUST BE 5 YEARS OLD ON OR BEFORE SEPTEMBER 1<sup>ST</sup> TO BE  
ELIGIBLE FOR KINDERGARTEN

ALL REGISTRATIONS SHOULD INCLUDE THE FOLLOWING:

**A. Complete Student Data Card**

**B. Proof of Academic Grades from previous school**

Last report card, any standardized test scores, and/or any pertinent or necessary information for student is in a special education program...(IEP/EP, FCAT scores, progress report)

**C. Proof of Birth-** Birth document must be verified by registrar using birth verification stamp for authenticity purposes.

*Must provide one of the following:*

- 1. Original birth certificate- Must be original; hospital certificate not acceptable
- 2. Passport

**D. Proof of Address-** Must provide **two** of the following:

- 1. Warranty Deed
- 2. Current Homestead Exemption
- 3. Electric deposit receipt or electrical bill, showing name and service Address
- 4. Lease Agreement- Fully executed lease

**E. Health Requirements**

- 1. Student Health Examination – DH 3040 yellow form health examination performed within one year prior to enrollment Clinical TB screening/results
- 2. Florida Certificate of Immunization – HRS 6080 blue card from a private doctor or local health care provider

## ***REQUIRED RESIDENCE DOCUMENTATION FOR REGISTRATION***

TWO OF THE FOUR BELOW ARE REQUIRED FOR REGISTRATION

1. Broker's or attorney's statement of parents' purchase of residence, **or** properly executed lease agreement.
2. Current Homestead Exemption card.
3. FPL Electric deposit payment receipt or electric bill, bottom portion, showing name and SERVICE ADDRESS. If an electric deposit payment receipt is used as verification, the electric bill, bottom portion, must also be submitted to the school within 40 calendar days after registration. Failure to submit this electric bill, bottom portion, within 40 calendar days, will result in revocation of the transfer.
